**Architectural Requests** 

The Arizona State Legislatures passed new laws this year that affect how HOA committees must operate. Due to these new laws, this also affects how homeowner Architectural Requests are reviewed. The new law dictates that all HOA committee meetings be open to the public, therefore all Architectural Reviews must be reviewed (approved or denied) in these meetings.

#### Q: How does this affect the homeowner?

The Committee has decided to schedule one meeting per month during which all requests will be reviewed. In order for a request to be reviewed during the monthly meeting, the request must be received by Preferred Communities at least 48 hours prior to the meeting. If not it is not received in time, it will be reviewed at the next meeting.

This means that homeowners need to plan ahead as the committee is not able to review a request on a moments notice.

Homeowners need to remember that all changes to a lot or outside of a house that is visible to neighboring property must be approved by the architectural committee prior to making the change. If a change is made without approval, the homeowner may be required to restore the Lot or house to the original state. Save yourself and the committee a hassle—submit your request. Architectural Committee Meetings will be held once a month, on a Saturday morning. The committee will meet at the Greenbelt in Phase I at 9:00 AM on the scheduled day. All homeowners are invited to attend, & listen to the committee discussions and decisions. However please keep in mind that this is not a forum for homeowners to request appeals or discuss requests that were denied. Homeowners must submit all appeals in writing to Preferred Communities, and the appeals will be reviewed by the Board of Directors.
