- 3. Parking Variance requests will be automatically denied if the garage is being use in any way that prevents the number of vehicles design to hold from being parked in the garage.
- 4. The Board will not grant permanent Street Parking Variances. IF a parking variance is granted, it will be on a temporary basis only.
- 5. Every request is reviewed on a case by case basis.
